- After written acceptance by Transatlantic Events, the sponsor must provide the sponsorship funds, logo image (in the format required by Transatlantic Events) and other details required (such as correct use of the sponsor's name, trademarks, etc) to Transatlantic Events within 30 days of receipt of acceptance.
